Inflatable Assault Course	Injury caused by contact with other Participants	Trained MeagBounce operators are to ensure that only 2 x personnel use the obstacle course at any one time and will only let 2 x personnel starts when previous 2 x personnel have exited. The trained MeagBounce operators will also keep the participants moving in the same direction. No personnel are allowed to climb on the sides; they will be supervised by the trained operator.	1	2	2	None
